#### "Planned Giving"

While bequests constitute 80 to 90 percent of all gifts from estates, there are many other options.

"Planned giving" professionals deal in products such as gift annuities and charitable trusts, some of which offer income during your lifetime with a gift to a designated charity upon your passing.

Each OCTA Trails Legacy Society member will receive:


- A special Trails Legacy Society pin.

#### Sample Bequest Language

The following language can aid you and your attorney or financial advisor in preparing your bequest to the **Oregon-California Trails Association.** 

I give, devise and bequeath to the Oregon-California
Trails Association, nonprofit corporation organized in
accordance with the laws of the State of Colorado, for
the purpose of supporting its efforts to preserve
overland trails, (a) the sum of \$;
or (b) the following described property
; or (c) (%
of) the rest, residue and remainder of my estate.

#### **Outright Bequest**

This bequest shall be used to further the purposes of the Oregon-California Trails Association in its trails preservation efforts, without restriction.

#### **Designated Bequest**

The property comprising this gift may, for investment purposes, be merged with any of the general investment assets of the Oregon-California Trails Association, but the gift shall be designated for use within the terms of the following specific endowment fund:

Heritage Fund Loomis Preservation Fund Martin Legal Fund

#### Bequest To Establish A New Endowment Fund

The gift shall be entered in the Association's books and records as the \_\_\_\_\_\_\_ Endowment Fund, and shall always be so designated. Distributions from the fund shall be used for the follow purposes:

## If you select a specific purpose for your gift, inclusion of the following sentence will ensure that the bequest remains useful if circumstances change in the future:

If, in the judgment of the OCTA Board of Directors, changed circumstances should, at some future time, render the designated use of this fund impracticable, unwise or inappropriate, then the Board shall use the fund to further the objectives and purposes of the

Oregon-California Trails Association, giving consideration to my special interest as described above.
